Notice is hereby given that the governing Body of the City of Gregory, Texas will hold a Regular Meeting in the 13 day of January 2025, at 6:30 p.m. in the Council Chambers of the Gregory City Hall located at 310 Ayers St., Gregory, Texas. Pursuant to Texas government Code Section 551.127, a member of the City Council intends to participate in this meeting by videoconference call. A quorum of the City Council and the Councilmember presiding over the meeting shall be present at the location stated above, and said location shall be open to the public during all open portions of the meeting. An audio recording will be made of this meeting, and be available to the public.

The public will be permitted to offer public comments as provided by the agenda and as permitted by the presiding officer during the meeting. Should there be more than five (5) persons to speak on a particular issue, they need to select one (1) representative to speak. Your presentation will be limited to three (3) minutes. Written comments may be submitted to City Secretary [norma.garcia@gregory-tx.com](mailto:norma.garcia@gregory-tx.com) up to two hours before the meeting. An audio recording of meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request.

Please be advised that the open meetings act prohibits the city council from responding and discussing your comments at length. The law only authorizes them to do the following:

- Make a statement of factual information.
- Recite an existing policy in response to the inquiry.
- Advise the citizen that this subject will be placed on an agenda at a later date.

No council member, staff person, or members of the audience shall berate, embarrass, accuse, or show any personal disrespect for any member of the staff, council members, or the public at any council meeting. This policy is not meant to restrain a citizen's first amendment rights.


